A one year probation period will begin on the official starting date. Pay scale will be at the Lieutenant/part-time level per salary schedule 26. Equipment to be provided by the Russell Township Police Department as appropriate. Mr. Gabram seconded the motion and it passed unanimously.* 

**SUPPLEMENTAL APPROPRIATIONS:** *Mr. Gabram made the motion to adopt Resolution number 2017-14: Supplemental Appropriations for the fiscal year ending December 31, 2017. Mr. Mueller seconded the motion and it passed unanimously.*
