Just to reiterate a point in my email below, you will not be required to complete a separate resolution/ordinances for each individual salt contract. If you are participating in the summer contract, when we ask for your winter quantities in late April/early May you can simply attach the same approved resolution/ordinance again when completing the Winter participation form.

You are receiving this email as notification that the Participation Form for the **ODOT SUMMER SALT CONTRACT (418-16)** has now been published. Again, this notification is for participation in the Summer salt contract only. The Winter Use Contract (018-16) Participation Form will not be sent out until the end of April/beginning of May. As always your participation on either of these contracts is completely optional.

In addition to the information shared below in this email, you are also invited to attend a conference call by dialing (855) 215-2033 on Wednesday, March 11th at 2:00PM. During this call we will reiterate this communication and answer any questions you may have after reading through it.

ODOT has developed a new website (link highlighted below) where Political Subdivisions can submit their salt request forms AND approved Resolutions/Ordinances electronically. This year we will only be accepting requests through this website and you are required to attach your approved resolution/ordinance with your submission. If you do not attach your approved Resolution/Ordinance we will NOT accept your salt request. Your resolution/ordinance shall serve as your Political Subdivision's digital signature for the participation form and legal approval to participate. Therefore, we will make no exceptions to this requirement. Your completed Participation Form AND Resolution/Ordinance must be submitted by no later than **Friday**,

April 3rd. We fully understand that everyone's boards, councils, trustees, etc. meet at different times, however we will not be able to make any exceptions to this date requirement. We apologize if this causes any inconvenience.

Please note: You will be able to use the same approved Resolution/Ordinance as your Political Subdivision's approval to participate in BOTH the Summer (418-16) and Winter (018-16) salt contracts. We do not need a separate resolution/ordinances passed for each individual contract.

Here are a couple of notes about this year's Summer salt contract:

- a. The summer salt contract will go out for bid on April 6th and bids will open around May 5th. We will share the bid results shortly thereafter.
- b. You will be required to purchase 100% of your requested tonnage. You will not be given an opportunity to remove or reduce your requested tonnage from the contract after the bid has been issued on April 6th.
- c. The contract will be effective from approx. mid-May through November 30, 2015.
- d. You must have all salt orders placed with your awarded salt supplier by no later than August 15th. If you do not place your order by August 15th your salt supplier will not be obligated to supply you with any salt.
- e. Your awarded salt supplier will have the entire contract period to deliver your requested tonnage, however, it will be a requirement that they have at least 50% of your ordered tonnage delivered by October 15th.
