Medic Vehicle Replacement

I am writing to request the replacement of the Russell FD's oldest Paramedic response vehicle.

The current medic vehicle, that is scheduled to be replaced, is a 15 year old, 2003 Ford Explorer with 91,815.0 miles and 6,531.9 Hours.

This vehicle replacement is budgeted for 2018 under the EMS secondary vehicle line item and is identified for replacement in the 2014-2017 RFD Vehicle Service Life Schedule.

Cosmetically the vehicle appears fair, the body and the frame is poor with both entire rocker panels rotted out, DS rear fender well is rotted out, PS fender well has heavy rust, rust through on outer DS fender, rust through on all lower door panels and lower inner front fenders, rust through the top of the windshield with water leakage, heavy rust on the rear underside compartment, and heavy rust on the inner frame, welds and attachment points.

This vehicle has no current engine or transmissions problems but is having difficulty with the charging and electrical system.

The replacement vehicle is a 2019 Ford Expedition totaling \$41,887.00 from Statewide Ford.

Up-fitting the vehicle will be additional and handled by HPS, the same vendor Russell Police utilizes and vehicle compartmentation will be handled by Hendrickson.
