

Please see the appended screen capture. As we discussed earlier today, there are two POLs at the entrance to the Red Raider development on Clydesdale Trail at Kinsman Road. Please confirm the following:

- Russell Township is interested in to obtaining a quote to reactivate CXC-605403 only on the northeast corner of SR 87 (Kinsman) and Clydesdale Trail (and NOT CXC-605402, on the opposite corner).
- 2. Russell Township also would like to rotate the arm 90 degrees and increase the wattage/lumens of the replacement fixture to illuminate more of the intersection.

I checked CEI Billing records and the Red Raider HOA closed out the POL account in March 2013. Apparently, following the installation of a replacement bulb(s) this past October, the lights were blocked from further action as neither POL is assigned to an active account.




