Re: Lap Top Computers

The Department's lap-top computers are used in the cruisers as a Mobile Data Terminal-MDT, and have become a basic tool in a police vehicle.

The MDT is used primarily to access LEADS, and as you can imagine, this piece of equipment has to withstand the conditions of everyday use, ex: extreme heat, cold and the constant moving and bouncing around in a police vehicle.

I recommend the Panasonic Toughbook Brand, as they are designed for this durable use in the field and our history with the brand since 1998.

The Department's current generation of MDT's, were purchased for \$17,239.64 and implemented in February 2012, and is a Panasonic CF-19 Model, which is a Fully Rugged model with the Touch-Screen and Back-Lit Keyboard.

After reviewing various models with a vendor, I recommend the Panasonic CF-33 Model, which is the Fully Rugged model with the Touch Screen and Back- Lit Keyboard, and would integrate with the Department's new - Arbitrator In-Car Camera System, which was implemented in February 2019.

This project is part of the Department's 5 year planning.
