The voting booths, tables and chairs, should be placed in the proper location PRIOR to the day of the election. The Board will need access to the building(s) prior to and following the election for the placement and storage of the privacy booths and other election equipment. Each precinct will need 2 large tables and 4 chairs.

The Board makes this application pursuant to R.C. 3501.29 which states: "Upon Application of the Board of Elections, the authority which has the control of any building or grounds supported by taxation under the laws of this state, shall make available the necessary space therein for the purpose of holding elections and adequate space for the storage of voting booths, without charge for use thereof. A reasonable sum may be paid for necessary janitorial service".

No person will be permitted to loiter, congregate, or engage in any kind of election campaigning within the area of the polling place and the small flags placed on the thoroughfares and walkways leading to the polling place, or if the line of electors extends beyond the flags, within ten feet of any elector in line. R.C. 3501.35 and R.C. 3501.30.
