RESOLUTION TO CERTIFY PETITION TO COMMON PLEAS COURT—CERTIFICATE

Board of Trustees of Russell Township, Geauga County, Ohio

WHEREAS, a petition having been duly presented to the Board of Trustees of Russell Township, Geauga County, Ohio, pursuant to Ohio Revised Code Section 511.18, praying that the Board proceed pursuant to law to organize a park district contained within the unincorporated area of the township, and establish a free public park within the township; and

WHEREAS, the Board of Township Trustees, after due examination, finds that the petition has been signed by persons who are electors of Russell Township, including all municipal corporations therein, to a number equaling or exceeding one-tenth of the total vote cast in the township at the general election next preceding its filing; and

WHEREAS, the entire park district at issue herein is contained within the unincorporated area of Russell Township.

NOW, THEREFORE, BE IT UNANIMOUSLY RESOLVED by the Board of Trustees of Russell Township, Geauga County, Ohio, that said Board certifies to the Court of Common Pleas of this county the fact of the filing of a sufficient petition pursuant to Ohio Revised Code Section 511.18.

BE IT FURTHER RESOLVED that the Fiscal Officer of the Russell Township Board of Trustees is hereby instructed to transmit a certified copy of this resolution and certificate to the Geauga County Court of Common Pleas.



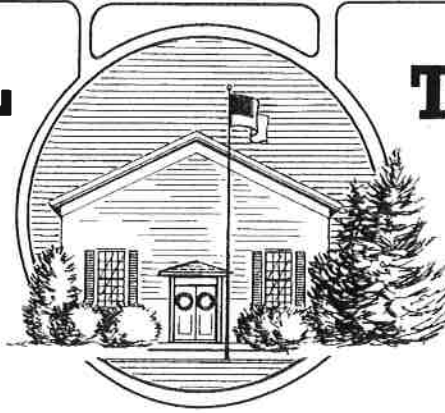

Dear Geauga County Board of Elections:


A large group of our Russell Township citizens has presented us with a petition to create an ORC Section 511 Park Board within our township.
