A RESOLUTION AUTHORIZING LEGAL REPRESENTATION AND PARTICIPATION IN PRO-RATA BILLING WITH FREEMAN, MATHIS & GARY LLP

The Board of Trustees of Russell Township, Geauga County, Ohio, met in regular session on the <u>2nd day of June</u>, <u>2022</u>, at the Russell Town Hall with the following members present: James Mueller, Matt Rambo, Kristina Port.

WHEREAS, the Russell Township Board of Trustees (the Board) has been party to legal action (*Ohio Insurance Services Agency, Inc. v. Board OH Public Entity Consortium Health, et al.*; Case No.: 18 CV 000788, Franklin County, OH) as former members of OPEC-HC; and

WHEREAS, the Board, was previously represented by Chenee M Castruita, Esq. and Elisabeth Gentile, Esq. of Mazanec, Raskin & Ryder L.P.A. from February, 2018 through Dec 31, 2021; and

WHEREAS, the Board, has been represented by Chenee M Castruita and Elisabeth Gentile of Freeman Mathis & Gary, LLP since Jan 1, 2022 at a rate of \$150 per hour; and

WHEREAS, the Board considers it advisable and necessary that additional counsel continue to be retained: Elisabeth Gentile, Daenayia Harris and Paul La Fayette of Freeman Mathis & Gary, LLP at a rate of \$250 per hour, on a pro-rata basis; and

WHEREAS, such pro-rata will be calculated based on the total fees charged by Elisabeth Gentile, Daenayia Harris and Paul La Fayette in representation of Russell Township in the subject OPEC-HC case, divided by thirty-eight (the number of OPEC-HC clients represented by FMG); and

WHEREAS, it is the desire of the Board that such pro-rata billing to commence as soon as practical.

NOW THEREFORE BE IT RESOLVED, that the Board does hereby:

Approve representation by Elisabeth Gentile, Daenayia Harris and Paul La Fayette of Freeman Mathis & Gary, LLP at a rate of \$250 per hour, on a 1/38th pro-rata basis; and

Approve the pro-rata billing to commence June 1, 2022 or as soon as practical after that date; and,
